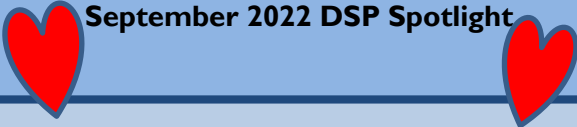

PNM to open October 2022!

As announced in May 2022, the Ohio Department of Medicaid will roll out a single-entry Provider Network Module (PNM) in October 2022. DODD's Provider Services Management (PSM) system will directly interface with PNM, which will become the single-entry point for all DODD providers. In preparation for this implementation, PSM will be undergoing modifications for PNM. As a result, it is necessary for DODD to stop accepting applications.

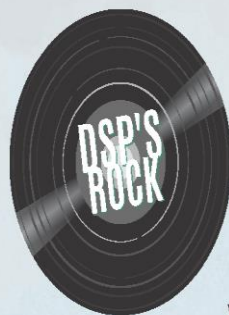
